The Contractor shall bear all costs of maintenance, including labor, parts and such other expenses as are necessary to keep the equipment in good operating condition, provided that the required repairs are not occasioned by fault or negligence of the Government. The charges for repair service will include the labor charge for the time during which repairmen are actually engaged in work and, when applicable, the charge for travel and/or transportation.

(a) Service Areas: The maintenance and repair service rates listed herein are applicable to any Government location within a 100 mile radius of the Contractor's service points. If any additional charge is to apply because of the greater distance from the Contractor's service locations, the travel required in the performance of services must comply with the Federal Travel Regulation or Joint Travel Regulations, as applicable, in effect on the date(s) the travel is performed.
