Project Director

Experience: Requires project experience and general experience as a recognized authority or expert on one or more business improvement fields, to include Project Management, Logistics or Engineering. Additionally includes experience of executive level coordination for both government and industry and establishing industry policies and best practices. Furthermore, experience is required in demonstrating ability and experience in management consulting and cross-team facilitation at the senior management level and the ability to provide guidance and direction to leadership for engagements.

Logistics Director

Education: Requires a Master's Degree with fifteen (15) years of experience, or a Bachelor's Degree with twenty (20) years experience.

Experience: Requires experience in leading and providing technical direction of multiple logistics projects that span the weapon systems life cycle. Additionally requires experience in providing guidance and direction for multiple projects in designing, implementing, and managing Logistics tasks. Furthermore experience is required in managing multitask projects of high complexity involving logistics and systems engineering. Experience is also required in primary interface with client management personnel regarding strategic issues and directing the completion of projects within estimated time frames and budget constraints. This involves coordinating all parties to

tasks, reviewing work products for completeness, adhering to customer requirements, and delivering presentations and leading strategic level client meetings.

Senior Logistics Expert

Education: Requires a Master's Degree with ten (10) years of experience, or a Bachelor's Degree with twelve (12) years experience.

Experience: Requires experience demonstrating the ability to provide Logistics expertise and direction for specific projects or sub-tasks. Capability to manage multitask projects of high complexity. Increasing responsibility in design, implementation, and management of Logistics. Interfaces with the client on project specific issues. Directs the completion of projects within estimated time frames and budget constraints. Coordinates project specific parties and reviews work products for completeness and adherence to customer requirements. Delivers presentations and leads client meetings.

Program Manager

Education: Requires a Bachelor's Degree from an accredited college or university or suitable experience substitution.

Experience: Requires a minimum of fifteen (15) years of experience with a Bachelor's Degree or twenty (20) years of experience without a Bachelor's Degree, in senior level positions responsible for program management on a multi-functional team and administration of a major Integrated Logistics Support (ILS) program during a job assignment in an Acquisition Command or supporting an acquisition command. This must include specific ILS disciplines, as well as work in developing program controls and management procedures. Must include experience demonstrating ability in supervising, directing, reviewing and other-wise coordinating all work performed. Additionally, experience is required performing technical analysis of Department of Defense (DoD) logistics support.

Senior Logistics Analyst

Education: Requires a Bachelor's Degree from an accredited college or university or suitable experience substitution.

Experience: Requires a minimum of ten (10) years of experience with a Bachelor's Degree or fourteen (14) years of experience without a Bachelor's Degree demonstrating the ability to provide Logistics guidance and direction for specific sub-tasks of a project. Requires experience as subject matter expert in analytical techniques and application to several key analytical and Logistics areas with increasing responsibility in implementing Logistics, interfacing with the clients on a day-to-day basis, supporting the completion of project specific tasks within estimated time frames and budget constraints and presenting results to clients.

Project Support Analyst

Assists in preparing management plans, reports, and deliverables. Assists in coordinating schedules to facilitate completion of tasks, training sessions, deliverables, and briefings. May perform analysis, development, and review of program administrative procedures. Orders materials and supplies for consulting, facilitation, survey, and program management engagements.

Senior Clerical Assistant

Education: Requires a High School Diploma.

Experience: Requires a minimum of three (3) years of experience. Uses greater judgment and initiative to determine the approach or action to take in non-routine situations. Composes correspondence on own initiative about administrative matters; prepares materials needed for conferences, correspondence, meetings, etc; reads regulations and directives and takes action or refers those actions that are important to the staff, prepares special or one-time reports, summaries, or replies to inquiries, selecting relevant information from a variety of sources such as reports, documents, correspondence, other offices, etc., under general directions; requests information needed from others for periodic or special conferences, reports, inquiries, etc.

Clerical Assistant

Education: Requires a High School Diploma.
