DESCRIPTION OF SERVICES

SIN 541614 – Deployment, Distribution and Transportation Logistics Services

Services include the following: Deployment Logistics such as contingency planning, identifying/utilizing regional or global resources, integrating public/private sector resources, inventory/property planning, movement, storage, end-to-end industrial relocation/expansion services, and deploying communications and logistics systems to permit rapid deployment and management of supplies and equipment; Distribution and Transportation Logistics Services such as Planning and designing, implementing, or operating systems or facilities for the movement of supplies, equipment or people by road, air, water, rail, or pipeline.

Under this SIN, Deployed Resources, will offer turn-key base camps inclusive of billets, HVAC, food service, ablution, laundry, administrative, MWR, power, potable water, sewer services and associated support thereof. Rates are based on a per person per day schedule and can be found on page 9.

SIN ANCILLARY – Ancillary Supplies and Services

Includes ancillary repair and alteration services ordered in conjunction with the delivery, or installation of products or services. These services are non-complex in nature, such as routine painting, carpeting, simple hanging of drywall, basic electrical or plumbing work, landscaping. SIN OLM Order-Level Materials

OLMs are supplies and/or services acquired in direct support of an individual task or delivery order placed against a Schedule contract or BPA. OLM pricing is not established at the Schedule contract or BPA level, but at the order level. Since OLMs are identified and acquired at the order level, the ordering contracting officer (OCO) is responsible for making a fair and reasonable price determination for all OLMs. SUBJECT TO COOPERATIVE PURCHASING.

OLMs are procured under a special ordering procedure that simplifies the process for acquiring supplies and services necessary to support individual task or delivery orders placed against a Schedule contract or BPA. Using this new procedure, ancillary supplies and services not known at the time of the Schedule award may be included and priced at the order level.





SPECIAL ITEM NUMBER (SIN) 541614

Under this SIN, Deployed Resources, LLC (DR), offers turn-key base camps inclusive of billets, HVAC, food service, ablution, laundry, administrative, MWR, power, potable water, sewer services and associated support thereof.

Included in Turn-Key Base Camps

Billet Facilities

Billet facilities are provided in soft wall engineered structures. These structures are comprised of aluminum frames and membrane panels that are configured in 40′, 66′, 80 and 100′ widths and in lengths in increments of 20′ or 30′ to whatever length the site conditions dictate. Each facility comes with engineered wooden flooring, lights, doors with exit signs and fire safety devices per NFPA 101. All tented structures are provided with manufacturers engineering data capable of supporting Class C wind loading.

Engineered Soft Wall Structures

Soft wall structures consist of climate-controlled frame tent facilities with floors, lights, doors and fire extinguishers. Units are provided with cots and/or metal-framed beds and mattresses, cell phone charging stations, and linen service. Tents are climate controlled to an ambient temperature of 68-74 degrees Fahrenheit and are sized to provide 50 square feet of space per person.

Food Service

Base Camp Food Service includes a full-service kitchen providing 3 hot meals per day. Boxed/prepared lunches are also available for workers who are not in the camp during lunch hours. Each facility is operated IAW USDA Food Codes and Army Food Service Programs. Meal menus are based on a 21-day rotation. The feeding program is overseen by trained chefs and food service supervisory personnel. All associated equipment to operate the kitchen and dining facility are provided. Equipment includes refrigerated and dry storage, washing and preparation areas, baking areas and serving areas. A Dining Facility is also provided with floors, doors, lights, fire prevention devices and climate controls. The Dining Facility is available for meetings during non-operational periods. 24-hour beverage service (coffee, juice, etc.) is provided. The kitchen and dining facility both come equipped with a hand wash unit at the entrance that is regularly stocked with soap and paper towels.

Temporary Power and HVAC

Diesel powered generators to sufficiently power all Base Camp related equipment and facilities are provided. Distribution and outlets are routed as required by site configuration in accordance with the National Electric Code. All electrical equipment is NEMA 3R rated for outdoor use and installation and trained electrical technicians perform monitoring of the electrical systems. ASME rated HVAC units are provided for all occupant facilities to ensure satisfactory temperatures are always maintained. All ducting is sealed to prevent contamination and connections to structures are made with tight fitting transition hardware. Heating is provided to ensure an ambient temperature of at least 68 degrees Fahrenheit and air conditioning is provided to ensure an ambient temperature of at least 74 degrees Fahrenheit. Diesel fuel is provided by the customer.

Ablution and Hygiene

Showers and toilets are typically provided for occupant use at a rate of one showerhead per fifteen people and one toilet per ten people. Soap and paper towels at the hand-wash stations and laundry detergent for the laundry area are included. All facilities are sanitized and cleaned daily.

Water System

Water is supplied from onsite potable. DR will connect and install a distribution system to support kitchens, showers, laundries, lavatories, and other camp facilities. The water supply system operates at a pressure capable of producing a minimum of 12 psi at the furthest point of the system. All water related equipment is NSF61 potable water rated and water quality testing is performed weekly. The weekly analytical testing is subcontracted to a local environmental





lab. All quality controls and inspections are performed in accordance with AWWA, EPA and DOH standards for potable water systems.

Wastewater

All wastewater is connected to onsite approved sewer locations or collected in tanks via secure macerator pumps and closed piping systems.

Morale Welfare & Recreation (MWR)

A tented facility with equipment for reading and relaxing that includes Direct TV, wireless-internet, magazines, newspapers, and a DVD library for use by camp occupants. There are tables and chairs for groups to gather and relax as well as fitness equipment for strength and aerobic training in an adjacent area. Cell phone charging stations are also located in the MWR tent.

Site Lighting

Exterior lighting is provided via diesel light towers capable of providing 4000 watts of illumination. Any existing onsite lighting is utilized when possible.

Dumpster/Waste Facilities

Dumpsters are provided for consolidation of trash. Dumpsters are removed and emptied at an approved disposal facility at least twice per week. 35-gallon garbage cans distributed throughout the camp are available for occupant use. These receptacles are emptied daily by camp maintenance staff.

Administrative Area

Administration areas are included for the camp management staff to work from. These areas are separate from camp facilities. The admin areas include check in/out stations for accurate control of camp inhabitants. Camp information boards, shuttle service and postal drop off/pickup are located at the administrative area.

Support Staff

Support crew, vehicles and equipment to service DR or other equipment.

SPECIAL ITEM NUMBER (SIN) ANCILLARY

Under this SIN, Deployed Resources, LLC (DR), offers the following ancillary items that can be utilized to further compliment the Turn-Key Base Camps offered under SIN 541614. Ancillary items offered by Deployed Resources are located within the pricing for turn-key base camps as well as broken out separately within this SIN. Providing these services as additional items allows customers the flexibility to add or remove services as needed to further tailor base camps to meet individual needs.

DR 207 Mobile Shower Unit, 6/7 Heads, H/C Water

Mobile Shower Unit containing six (6) to seven (7) shower heads with Hot and Cold Water. All units are sanitized and cleaned daily. Showers are typically provided for occupant use at a rate of one showerhead per fifteen people.

DR 206 Mobile Laundry Unit, 6 Stacker, Washers, and Dryers

Mobile Laundry Unit consisting of six (6) stacker washers and dryers. Laundry detergent is included. Laundry Units are sanitized and cleaned daily.

Support Staff

One (1) Support Staff crewmember to provide service to a DR base camp or to other equipment.

Vacuum Sewage Truck with Operator

One (1) Vacuum Sewage Truck with Operator to service wastewater tanks once per day.

Potable Water Truck with Operator

One (1) Potable Water Truck with Operator servicing holding tanks once per day. All quality controls and inspections are performed in accordance with AWWA, EPA and DOH standards for potable water systems.

DR 360 Dining Facility, 300 PAX

A Dining Facility with floors, doors, lights, fire prevention devices and climate controls sufficient to support 300 personnel. The Dining Facility is equipped with a hand wash unit at the entrance that is regularly stocked with soap and paper towels.

Mobile Kitchen Unit

Mobile Kitchens Unit containing full exhaust hoods and ANSUL fire suppression systems, interior lighting, HVAC, refrigeration & dry storage, dual convection ovens, six-burner range, tilt skillet, warming cabinets, prep areas, three-bay sink, a hand-wash sink, and an easily removable grease trap.

The Mobile Kitchen Unit includes power, propane, wastewater storage, and a hot water heater with potable water supplied from potable water available on site.

The Mobile Kitchen Unit is suited to handle meal preparation for 300 personnel per meal.

Meal, Breakfast, Hot (300 or more per day)

Hot Breakfast Meal IAW USDA Food Codes and Army Food Service Programs. Meal menus are based on a 21-day rotation. Meals are overseen by trained chefs and food service supervisory personnel. Pricing is based on orders of 300 or more per day.

Meal, Lunch, Hot (300 or more per day)

Hot Lunch Meal IAW USDA Food Codes and Army Food Service Programs. Meal menus are based on a 21-day rotation. Meals are overseen by trained chefs and food service supervisory personnel. Pricing is based on orders of 300 or more per day.





Meal, Dinner, Hot (300 or more per day)

Hot Dinner Meal IAW USDA Food Codes and Army Food Service Programs. Meal menus are based on a 21-day rotation. Meals are overseen by trained chefs and food service supervisory personnel. Pricing is based on orders of 300 or more per day.

Sleeping Cots, 300LB, Nylon/Aluminum

Sleeping Cot rental for one (1) day. Cots are constructed from Nylon and Aluminum frames capable of supporting 300 pounds.
