Provides expert advice, assistance and guidance on major improvement projects such as: • Major process improvements or re-engineering efforts • Leadership development at a high level • Steering systems and/or leadership systems to manage major change • Design of appropriate methodologies for conducting services tailored to meet the unique needs of the project • Alignment of different areas and efforts into a holistic approach for overall organizational improvement Minimum education: Masters degree or other graduate degree in relevant discipline (for example a law degree); may substitute experience for graduate work on a basis of two years of experience for one year of graduate work.
