23. Environmental Attributes: ISO 14001 and ISO 9001 InterfaceFLOR is currently registered to two international standards for quality and environmental concerns. ISO 9001 is a quality management system model that IFS received registration to on May 3, 2002.

ISO 14001 is an environmental management system model and since environmental stewardship is at the core of IFS' philosophy, the company pursued and received registration to this standard first, on June 18, 2001. IFS uses internationally recognized Underwriters Laboratories Inc. as its registrar.

In addition to these two international standards, InterfaceFLOR has recently received notification from the Environmental Protection Agency that its application for membership in the EPA's National Environmental Performance Track program has been accepted. This program is "designed to recognize and encourage top environmental performers - those who go beyond compliance with regulatory requirements to attain levels of environmental performance and management that benefit people, communities and the environment."

Performance Track closely mirrors ISO 14001 wherein it requires a company to comply with established environmental management requirements within its entry criteria. There are four basic areas that a company must comply:

- A company must have adopted and implemented an environmental management system (EMS) that includes the elements specified in the Performance Track Entry Criteria;
- Is able to demonstrate specific environmental performances and commit to continued improvement;
- Commits to public outreach and performance reporting; and
- Has a record of sustained compliance with environmental requirements.
