- Claims:** Before accepting goods from carrier YOU MUST EXAMINE SHIPMENT CAREFULLY. All claims should be filed by you immediately with delivery carrier.
- Restocking:** Merchandise may be returned freight prepaid in original or equivalent cartoning. Upon receipt, Blockhouse will inspect and note defects or damage. Blockhouse will have six months to attempt to sell merchandise. Any unsold merchandise shall have a 25% restocking charge.
- COM:** Based on 54" plain. Patterns or prints requiring matching, consult factory for additional yardage requirements.
- NOTE:** All dimensions are approximate. All weights given are approximate unpacked weight.

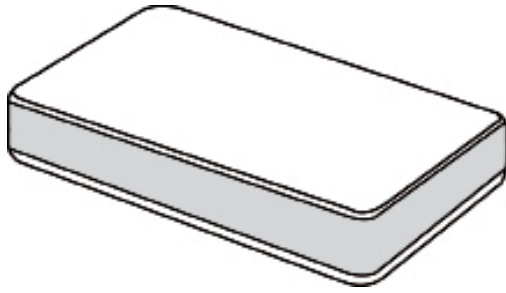

The warranty, which runs from the date of manufacture, covers defects in materials and craftsmanship found during normal usage of the products during the warranty period. If a product is defective, and if written notice of the defect is given to Blockhouse within the applicable warranty period, Blockhouse at its option will either repair or replace the defective product with a comparable component or product.

## LIMITED LIFETIME WARRANTY

The Limited Lifetime Warranty applies to normal useful life in a typical multi-use environment unless specified as an exception. This warranty does not apply to damage caused by carrier, alterations to product not expressly authorized by Blockhouse, nor to product considered to be of a consumable nature such as fabrics, foam and related products. It also does not apply to "Customer's Own Material" (ie., material supplied by the customer that is not a standard Blockhouse product offering) used in the manufacture of Blockhouse products. Blockhouse does not warranty the matching of color, grain or texture, except to within commercially acceptable standards. A product will not be considered defective, and Blockhouse will not be obligated to replace it, if the

product is subject to any of Blockhouse's written planning, installation or users guides, and is not installed or used as recommended therein.

EXCEPT AS STATED ABOVE, BLOCKHOUSE MAKES NO EXPRESS OR IMPLIED WARRANTIES AS TO ANY PRODUCT AND IN PARTICULAR MAKES NO WARRANTY OF FITNESS FOR ANY PARTICULAR USE. AT BLOCKHOUSE'S OPTION, PRODUCT REPAIR OR REPLACEMENT IS THE CUSTOMER'S EXCLUSIVE REMEDY FOR ANY AND ALL PRODUCT DEFECTS.
