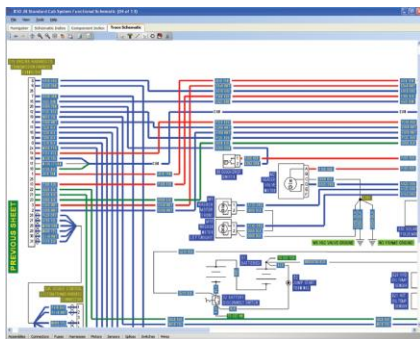
Corporate Overview

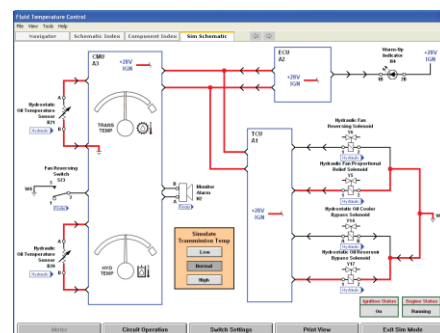

This state-of-the-art technology enables the maintainer/technician to effectively troubleshoot all of the wiring, cabling, backplane harnesses and electro-mechanical interfaces associated with any system.

The **p2Sim™** application is a fully interactive, emulation of all circuitry associated with a specific system function (e.g., master power). It is designed for maintainers by maintainers to impart their professional knowledge of how complex circuitry reacts under varying, selectable conditions. This custom-designed technology insertion is extremely effective both on the job as a troubleshooting / training tool and in the traditional classroom as a high quality teaching aid.

When these two applications are integrated as a common



package, a troubleshooting/training tool becomes available to the maintainer/trainer that is second to none. Reductions in Mean Time to Repair (MTTR) of up to 40%+ are achievable through the use of these combined troubleshooting / training applications.

Note: There are no recurring run time or licensing fees associated with the DST software application.

p2Trace™ Development:

DSS will process all customer provided schematics to be accessed and used within the TraceMode selection of DST. The p2Trace™ application is primarily designed to assist and guide both the expert and novice maintainer / technician in understanding how a selected circuit was designed, as well as provide a fully interactive data source to assist in accomplishing effective troubleshooting and maintenance procedures.

The p2Trace™ application initially takes the Original Equipment Manufacturers (OEM) provided schematic data and converts it from its current source (e.g., paper, .pdf, CAD, etc) into an intelligent Computer Graphic Metafile (CGM) Level 4, intelligent format without making any changes whatsoever to the original source data, after which a comprehensive data base management system (e.g., MS Access, Oracle, etc) is custom designed to accept all of the associated schematic meta data. The schematics are then professionally analyzed by a staff of electrical, hydraulic and pneumatic engineers and all wires are initially assigned a default color (e.g., Red – Power / Blue – Signals / Green – Grounds) and all hoses, connectors, etc. are cataloged for entry into the database, The schematic may be cosmetically colorized to identify functionally associated areas, if desired. Fully interactive sheet links are developed to ensure continuity of a selected circuit continues uninterrupted from start-to- finish without any loss of functionality. Fully interactive, sort capable listings of all system components, schematic sheets, reference designators, wire lists and all other associated meta data are then incorporated into the data base for instant recall. A fully interactive Help and retrievable History file is custom developed to support the p2Trace™ application. p2Sim™ Development:

The p2Sim™ application is primarily designed to assist and guide the novice maintainer /

p2Sim™ segregates individual circuitry into “function specific” diagrams (e.g., master power, lights, etc). The terms and conditions of this contract shall apply to all orders for installation, maintenance and repair of equipment in areas listed in the pricelist outside the 48 contiguous states and the District of Columbia, except as indicated below:

Not Applicable.

Upon request of the Contractor, the ordering activity may provide the Contractor with logistics support, as available, in accordance with all applicable ordering activity regulations. Such ordering activity support will be provided on a reimbursable basis, and will only be provided to the Contractor's technical personnel whose services are exclusively required for the fulfillment of the terms and conditions of this contract.

20. BLANKET PURCHASE AGREEMENTS (BPAs)

The use of BPAs under any schedule contract to fill repetitive needs for supplies or services is allowable. BPAs may be established with one or more schedule contractors.
