Maintain current Cardiopulmonary Resuscitation (CPR) or Advanced Cardiac Life Support (ACLS) certification. Physician – Internal Medicine

Physician – Psychiatrist

Physicians working in Psychiatry must have completed an undergraduate and medical school and receive the degree of MD or DO. For physicians who have completed medical school outside the U.S., the Educational Commission for Foreign Medical Graduates (ECFMG) is required. All physicians must complete a Residency Training Program approved by the Accreditation Council of Graduate Medical Education (ACGME). The physicians must be board certified in Psychiatry by the American Board of Psychiatry and Neurology or the American Osteopathic Board of Neurology and Psychiatry. For a physician to be considered board eligible, they are within 1-4 years after the completion of their residency. All physicians will have a minimum of BLS and preferably ACLS certifications.

Psychologist

Current, active, valid, and unrestricted medical license from a U.S. State; must be board certified in appropriate specialty. Minimum two years' experience within the past three years in the area of practice. Degree in medicine from an accredited school of medicine.

Registered Nurse – General

Pharmacist

Certification in specialty areas (geriatrics, etc.) is available but not required. License is state-based and all states use the NAPLEX exam or endorsement as the basis for licensure. Some states require a separate jurisprudence exam. Minimum twelve months experience in past 24. 2 years undergraduate pre-requisites plus 4 years of pharmacy school.

Physician Assistant

Must be certified by the NCCPA and licensed in one of the fifty states. They must be a graduate of an approved PA school. They also must maintain a current Advanced Cardiac Life Support (ACLS) certificate as well as a Basic Life Support (BLS) card. The provider must have a minimum of 12 months experience in the last 36 months.

Speech Therapist

C.E.U Certifications as required by state; BLS and/or ACLS required CPR certification required. Minimum one year of clinical experience. Master's degree in Speech Pathology from an accredited school.

Audiologist

C.E.U Certifications as required by state; BLS and/or ACLS required CPR certification required. Minimum one year of clinical experience. Doctoral or Professional degree in Audiology from an accredited school.

621-32

EMT

EMT must have completed the required course requirement for the said state and have passed the state required examinations with a minimum of 1 year of experience. Levels of EMT – Basic, Intermediate (undergo an additional 65-80 hours of training), and Paramedics (undergo an additional 600-1000 hours of instruction including clinical and field internships). BCLS and ACLS if applicable.

Dental Assistant

The dental assistant shall possess a Certificate or Associate Degree as a dental assistant/technician from a state accredited program and 1 year experience within the previous 3 years OR certification from a military dental technician or dental assistant “A”. Membership in good standing with the American Association of Dental Assistants with required continuing education.

Dental Hygienist

Graduation from an ADA accredited dental hygiene program. Valid dental hygiene licensure from at least 1 US state. Minimum 1 year experience in the previous 3 years.

Respiratory Therapist

Graduation from an approved program in Respiratory Therapy. Must obtain registration/certification and state licensure as required. 1 year of experience in the previous 2 years. AARC certification, state licensure if required, BLS/ACLS.

Physical Therapist

Graduation from an accredited Physical Therapy Program. Minimum twelve months experience in past 24 months. All providers will have successfully completed the certification process. ACLS: Preferred BCLS: Required

Occupational Therapist

Graduation from an accredited Occupational Therapy Program. Minimum twelve months experience in past 24 months. All providers will have successfully completed the certification process. ACLS: Preferred BCLS: Required

Licensed Vocational Nurse

LVN’s must have license verifiable through Board of Vocational Nurse Examiners and have at least one year experience in the last three years. Must be certified in CPR, ACLS, PALS.

621-39

Medical Technician

Medical Assistants must be certified and have at least one year experience in a medical setting. Must be certified in CPR.

621-40

Certified Nursing Assistant

CNA’s must be certified and must have at least six months experience in a medical setting. Must be certified in CPR.

Requires a two-year associate's degree. 1 year experience in the past 24 months in specialty Certified Optometric Technician. _

Bachelor's Degree in Social Work. May possess current social work certification through the Academy of Certified Social Workers (ACSW). Requires 1-2 years of experience in the field or in a related area. Current unrestricted license in one US State or Territory.

621-48 Health & Fitness Specialist/Dietician
Bachelor's Degree in related field. Requires 1 year of experience in related field. Possesses current CPR certification.

621-49 Surgical Technologist
Surgical technologists graduate with an associate's degree from an accredited program through ARC/STSA, a collaborative effort of AST and ACS, by CAAHEP. Must possess an approved certification by NBSTSA, CST, or other related certification, as applicable. BLS certification may be required dependent upon the agency's inclusion in the SOW and/or the PWS. Minimum of 1 year-experience in respective specialty, preferred.

621-50 Radiography – Diagnostic Imaging Technician
Registration through the American Registry of Radiology Technologists; BCLS, ACLS Specialty 1 year experience in the past 24 months in specialty. Graduate of an AMA approved school of Radiology, Nuclear Medicine, or Ultrasound.
