9. **Minimum Qualifications of Professionals:** See page 4 of this price list.
10. **Overtime:** 1.3 x the normal hourly rate for all hours worked over 40 hours in a week. Physicians receive the regular hourly rate.
11. **On-call:** Providers will receive \$6.00 per hour (this includes physicians & non-physicians). On-call includes telephone consultations. When on-call, the provider is to carry a beeper or cell phone and answers calls. The individual must be within 30 minutes of the facility or within a 30 miles radius of the facility, or as otherwise agreed with the ordering facility.
12. **Call Back:** If the on-call provider is required to return to the facility, the regular hourly rate applies and will be paid for each hour at the facility as a result of call back. The rate begins once the provider arrives at the facility and a minimum of one hour will be paid. Overtime rules apply for any hour exceeding 40 worked hours in a week, including regular hours and call back hours.
13. **Holidays:** 1.25x the hourly rate for non-physicians only. Physicians receive the regular hour rate for all hours worked on a holiday.
14. **Work Week:** Sunday through Saturday
15. **Background Investigations:** All providers must complete facility required documents for security clearance including NAC-I investigations, High Level, Secret, or Top Secret clearances. Statewide checks will include current and recent states of residence; states in which licenses are, or ever have been, held; any states in which services have been provided; statewide felony and misdemeanor checks; address trace; Nationwide Sex Offender Registry; National Criminal Database Search; and alias checks.
